Use Permit and Design Review application for the construction and operation of an iron salts (for water treatment and purification) manufacturing plant facility at the Corteva industrial complex located at 901 Loveridge Road, Pittsburg, California 94565. The subject parcel is zoned General Industrial (IG) and is designated Industrial in the City of Pittsburg 2040 General Plan. Assessor's Parcel Number: 073-220-049.
